The Direct Debit Guarantee

- This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.
- If there are any changes to the amount, date or frequency of your Direct Debit PSL re Camelford Leisure Centre will notify you five (5) working days in advance of your account being debited or as otherwise agreed. If you request PSL re Camelford Leisure Centre to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit, by PSL re Camelford Leisure Centre or your bank or building Society, you are entitled to a full and immediate refund of the amount paid from your bank or building society
 - If you receive a refund you are not entitled to, you must pay it back when PSL re Camelford Leisure Centre asks you to
- You can cancel a Direct Debit at any time by simply contacting your bank or building Society. Written confirmation may be required. Please also notify us.

Terms and Conditions

- A membership for a single family unit; either 2 adults + up to 3 under 18s or 1 adult + 4 Under 18s. Separate cards are issued to allow individuals of the membership to attend sessions alone (Session rules apply.)
- Concessions: Seniors 60+, individuals on means tested benefits or working tax credits. Students in full time education (upon presentation of student membership card, NUS card etc.) Also available to those referred by their GP upon presentation of a letter or other evidence (reviewed annually.)
- Joint memberships: A single membership for adults residing at the same address. Separate cards are issued to allow individuals of the membership to attend sessions alone.
- 17 & Under -- A single membership for those under the age of 18 (requires annual review.)
- All members entitled to vote at the AGM but only members aged 18 or over will be entitled to stand for election to the Board of Directors.
- Members must have completed a Safe User induction at Camelford Leisure Centre or be able to evidence that a safe user induction has been completed elsewhere. Safe User Induction to the Fitness Suite takes up to one hour to complete (by appointment) and is priced at £30 for non-members and £15 for members or users who proceed to take out a membership.
- Payment by alternative methods may be arranged. An administration fee may apply.
